**STEP TWO - Special Membership thru TCA WC Insurance Program if you do not belong to one of the above associations or do not wish to become a member of one of the above associations.**

You may join TCA in order to participate in the Workers' Compensation Program. In addition to participating in the Workers' Compensation program, you will be entitled to some of the benefits that accompany membership, including: Newsletters, participation in Legislative and Political activities, Legislative alerts, TCA communications network, invitations to local political receptions, and participation in the other Endorsed Programs of TCA. Dues to become a member are based on your total workers' compensation written premium level (after discounts or credits) on TCA WC Program's Premium Quotation Sheet as follows:

PREMIUM RANGE	ANNUAL DUES
\$1 to \$50,000	\$200
\$50,001 to \$100,000	\$300
\$100,001 to \$200,000	\$400
\$200,001 to \$300,000	\$500
\$300,001 to \$400,000	\$600
\$400,001 to \$500,000	\$700
Over \$500,000	\$1,000

Dues are set and subject to change by Texas Construction Association, not by the TCA WC Program.
